ORDER:

In the reference 1st read above, Government have issued "*THE ANDHRA PRADESH REGULATION OF ADMISSION OF CANDIDATES INTO POLYTECHNICS AND STATE-WIDE INSTITUTION RULES, 1988*".

2. In the reference 2nd read above, Government have issued revised pattern of admission into minority un-aided polytechnic colleges from the academic year 1993-1994.

3. In the reference 3rd read above, Government in Minority Welfare Department have issued certain Guidelines for issuing minority status certificate for making admissions and appointments etc., in Minority Educational Institutions.

4. In the reference 5th read above, the Hon'ble High Court of AP upon hearing the W.P.No.20958/2022 have suspended the G.O.Ms.No.135 Education (TE-1) Department, dated:19.04.1994 till further orders.

5. In pursuance of the suspension of G.O.Ms.No.135, Education (TE-1) Department, dated:19.04.1994, the Director of Technical Education A.P Mangalagiri, has submitted the proposal vide references 6th and 7th read above.

6. After careful examination of the proposal by the Director of Technical Education A.P, Mangalagiri, the Government have decided to adopt the G.O.Ms.No.75, Higher Education (EC) Department, dated:28.07.2011 for fixing the ratio of seats as 70:30 between the Convener quota and Management quota for the un-aided Minority Polytechnics. The procedure for admission to Minority Un-aided Polytechnics shall be as follows:

- a. 70% of the approved intake will be filled up with the POLYCET qualified candidates through web based counseling by the convener, initially by allotting seats to the respective Minority candidates and the remaining seats with non minority candidates based on POLYCET rank.

- b. The remaining 30% of the intake shall be regulated by the concerned Minority Polytechnics to admit the candidates belonging to the particular religious or linguistic minority. The selection shall be made strictly based on the rank obtained in the POLYCET. In the event of non-availability of Minority candidates the seats can be filled with the POLYCET qualified non-minority candidates.
- c. After completing the admission process, each College shall apply to the competent authority duly containing the full particulars of the students admitted under para-(6) clause-(b) above for ratification. The authorities, to whom details are submitted, shall verify the correctness of documents and if they find any irregularity, they shall call upon the colleges concerned to rectify the same. Any violation of the orders, the Managements will be held liable for action.

7. The Director of Technical Education, Andhra Pradesh and the Chairperson, State Board of Technical Education & Training, Andhra Pradesh, Mangalagiri, shall take necessary action accordingly.
